

**SOUTHLANDS BOULEVARDE 12 DAYS OF GIVEAWAYS (GAME OF CHANCE)  
TERMS & CONDITIONS (INCLUDES PRIVACY STATEMENT AND ENTRY FORM  
TICK-BOXES)**

1. Information on how to enter forms part of these terms and conditions.
2. Entry is only open to residents of Australia aged **16 years and older**. Employees of the Promoter and their immediate families and retailers within **Southlands Boulevard** and the retailers' employees and their immediate families are ineligible to enter. Promotion commences at **9:00am** on **Thursday 1 December 2016**. Entries close at **9:00pm** on **Monday 12 December 2016 (Promotion Period)**.
3. To be eligible, you must enter via at least one of the following methods during the Promotional Period:
