

Terms and Conditions including the Privacy Statement

Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Limited ABN 61 002 894 153, a division of Lendlease Corporation Limited ABN 32 000 226 228 with its registered office at Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo NSW 2000 (**Lendlease**). Permit Number LTPS/18/22595, NSW
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the Competition.
3. The following person(s) are ineligible to enter the Competition:
 - (a) employees of:
 - (i) any retailer within The Streets of Barangaroo
 - (ii) the Promoter; and
 - (iii) the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
 - (b) members of the Immediate Families of the employees referred to at paragraph 3(a).

This includes a Champagne tasting at Smoke Rooftop, a meet & greet with Head Chef Cory Campbell, a 'Chef's Table' dinner for two at Bea Restaurant, and paired wines to accompany your meal. 12. The Prize is not redeemable for cash.
13. The Prize is personal to the winner. It cannot be transferred, exchanged or otherwise dealt with.
14. The Promoter assumes no responsibility for lost, misplaced, destroyed or stolen Prizes once they are claimed.

Subject to Your Consumer Rights, the Promoter is not liable for any loss or damage however caused (including by negligence), suffered or incurred in connection with the Competition or any Prize. Any condition or warranty which would be implied by law into these terms and conditions is excluded.

 - (b) promptly destroy all entries received; and
