State	Expiration Date	Description
<b>California</b>	*Residential tenets who apply for rental assistance are protected from eviction until 6/1/22. Los Angeles County, City of Los Angeles, City of Oakland, and County of Alameda. (See description)	*Local eviction moratoriums may be in effect. Los Angeles County extended its residential eviction moratoriums until 12/31/22. The City of Los Angeles’s residential eviction moratorium is in effect until 12 months after the expiration of the city’s local emergency expires, which is still in effect. The city of Oakland and the County of Alameda have residential eviction moratoriums in effect until the expiration of each jurisdiction’s local emergencies.
<b>Massachusetts</b>	Boston 3/31/22 for residential tenants.	Residential tenets who apply for rental assistance are protected from eviction.
<b>Minnesota</b>		Residential tenets who apply for rental assistance are protected from eviction. *Local eviction moratoriums may be in place. Boston eviction moratorium for residential tenants expires on 3/31/22.

California	Expired-Residential evictions-9/30/21. Local protections for residential and commercial evictions - 9/30/21. Los Angeles County residential eviction moratorium until 12/31/22.	On 7/1/21 Governor Newsom signed a state budget into law which includes and extension of the state's residential eviction moratorium until 9/30/21. *Landlords are required to apply for rental assistance on behalf of tenants before filing for eviction. *Local eviction moratoriums may be in effect. Los Angeles County extended its residential eviction moratoriums until 12/31/22.
Colorado	Expired-11/20/20	On 10/21/20 the Governor issued an <a href="#">Executive Order</a> placing a moratorium on residential evictions.
Connecticut	Expired-6/30/21 *Residential tenants who apply for rental assistance are protected from eviction.	Tenants are protected from evictions while applying for rental assistance. Eviction moratorium expires on 6/30/21 when the state's health emergency expires.
Delaware	Expired-3/10/21	The Governor issued an <a href="#">Executive Order</a> on 6/8/20, allowing landlords to file residential evictions but orders courts to immediately stay proceedings.
District of Columbia	Residential eviction moratorium expired-1/1/22 Commercial eviction moratorium expired-3/31/21.	
Florida	Expired-10/1/20	The Governor extended an <a href="#">Executive Order</a> limiting residential evictions until 10/1/20.
Georgia	N/A	Georgia courts have been provided the <a href="#">flexibility</a> to determine if an eviction should proceed.
Hawaii	Expired-10/3/21	The Governor issued an <a href="#">Executive Order</a> suspending residential eviction court proceedings until 10/3/21.
Illinois	Expired-10/3/21	The Governor <a href="#">announced</a> the states eviction moratorium will expire on 10/3/21.

State	Expiration Date	Description
<b>Kansas</b>	Ended-5/28/21	The Governor issued an <a href="#">Executive Order</a> limiting residential evictions until the State of Emergency ends. The Kansas Legislature overrode the Governor’s veto to end the states eviction moratorium on 5/28/21.
<b>Kentucky</b>	Expired	Open-ended eviction moratorium repealed. 30-day notice to residential tenants required.
<b>Louisiana</b>	Expired-9/24/21	The Governor issued an executive order halting evictions until 9/24/21 in response to Hurricane Ida.
<b>Maine</b>	Expired	Evictions can proceed under an <a href="#">order</a> by the Governor expanding notice of eviction timeframes.
<b>Maryland</b>	Expired	The Governor issued an <a href="#">Executive Order</a> limiting evictions during the state of emergency. On 8/31/20, eviction court proceedings resumed. Tenants will be able to use COVID-19 and its economic impacts as a defense. This defense expires on 8/15/21.
<b>Massachusetts</b>	Boston 3/31/22 for residential tenants. *Residential tenets who apply for rental assistance are protected from eviction. Expired-10/17/20 Renters applying for rental assistance protected from eviction. Boston has a moratorium on evictions.	*Residential tenets who apply for rental assistance are protected from eviction. The Governor extended a legislative <a href="#">ban</a> on residential evictions until 10/17/20. * Boston issued a moratorium on evictions on 9/1/21. *Local eviction moratoriums may be in place. Boston evictions moratorium for residential tenants expires on 3/31/22.
<b>Michigan</b>	*Residential tenets who apply for rental assistance are protected from eviction.	*Residential tenets who apply for rental assistance are protected from eviction. The Michigan Supreme Court has issued and <a href="#">administrative order</a> placing conditions on evictions until 12/31/20.
<b>Minnesota</b>	Expired-7/14/21 Renters applying for rental	Tenants cannot be evicted while applying for rental assistance.

New Jersey	Expired-9/1/21-for residential tenants with household incomes below 120% of AMI. Expired-12/31/21-for residential tenants with household incomes below 80% of AMI.	The Governor signed legislation creating new eviction and foreclosure moratorium deadlines and special eviction protections for tenants who were directly impacted by the pandemic. New Jersey’s eviction moratorium will now continue through August for all state residents with household incomes below 120% Area Medium Income (AMI) and through the end of the year for certain households with incomes below 80% AMI. Court proceedings can continue during this time.

On 9/1/21 the New York Legislature extended the states moratorium on commercial and residential evictions and foreclosures until 1/15/22. *Local eviction moratoriums may be in effect.
<b>North Carolina</b>	Expired-6/30/21	The Governor issued an <a href="#">Executive Order</a> that places limits on residential evictions until 6/30/21.
<b>Oregon</b>	Expired-6/30/21 for residential tenants. Expired-9/30/20 for commercial tenants. Renters applying for rental assistance protected from eviction.	The legislature enacted <a href="#">HB 4213</a> , which prohibits evictions for residential and commercial tenants until 9/30/20. The Governor signed an <a href="#">executive order</a> prohibiting residential evictions until 12/31/20. The legislature extended this moratorium until 6/30/21. * Local eviction moratoriums may be in effect.
<b>Pennsylvania</b>	Expired-8/31/20	The Governor issued an <a href="#">Executive Order</a> that places residential eviction proceeding on hold until 8/31/20.
<b>Rhode Island</b>	Expired-6/2/20	The Governors moratorium on eviction shas expired.
<b>Texas</b>		*Local eviction moratoriums may be in effect.
<b>Vermont</b>	Expired-7/15/21	The Vermont legislature <a href="#">limited evictions</a> until 30-days after the state of emergency ends.
<b>Virginia</b>	Expired-9/7/20	The Virginia Supreme Court <a href="#">ordered a suspension</a> of residential evictions until 9/7/20.
