- United States The Dept of Homeland Security has recently posted an updated Form I-9. Organizations are required to use the new Form I-9 by May 1, 2020 we will be posting a position statement highlighting the new changes/posting date of the updated form I-9 by the end of March
- United States The Voluntary Self-Identification of Disability form expires January 31, 2020 – OFFCP has not posted a revised form, customers should continue using the expired form.

- Canada The publication of the Payroll Deductions Formulas Guide
   (T4127) after November 26, 2019 proposed two options in applying the dynamic formula for the federal Basic Personal Amount (BPAF) announced in the last federal budget
- India The finance bill proposes to provide an option for individual taxpayers to apply lower tax rates as per the new tax regime
